## SYLLABUS OF PH. D. COURSE WORK DEPARTMENT OF ENGLISH NAGALAND UNIVERSITY

### (Updated as per 39th AC Resolutions, dated December 2024)

The one semester course work for Ph.D. research as has been made mandatory by the UGC (in 2022), which is followed by the Department of English, Nagaland University. The DRC/RAC of the Department has decided to prescribe a course work consisting of four papers of a total of 14 credits duration. Each paper of 100 marks will be evaluated internally. Mark distribution for different papers is 60:40 which is common for all. 40 marks for assignments, and 60 marks for End Term Evaluation.

The internal examination which will be taken care of by the supervisors will consist of home assignment, written test, viva voce, field work, seminar presentation, group discussion, etc. The following is the area distribution of the course work.

# 1. Paper-I: Research Methodology (2+2)= 4 credits

#### Objective:

- i. The course aims to teach students the basics of research skills, and academic writing and also emphasizes on Computer Literacy for all students.
- ii. The students will be trained in the formal aspect of research methods, selection and phrasing of the topic, collection and ordering of materials and finally giving them an organic whole.

Unit-I:(a) Thorough acquiring of citation and bibliographical skills: APA & MLA styles and other citation methods.

(b) Research and Writing, Plagiarism, The Mechanics of Writing., Format of the research Paper, Documentation: Preparing the List of Works Cited, Documentation: Citing Sources in the Text, etc.

Unit-II:(a) Library Research: Use of library and internet sources, Location of information.

(b) Research as a Creative and Strategic Thinking Process, Managing the Process, Developing Your Research Question, Exploring Power and Ethics in Research, Indicators of Good research.

Unit-III: Working with Literature, Facilitating Change through Research, Data Collection, Data Management and Analysis, the Challenge of Writing-up.

Unit-IV:Research and Publication Ethics (RPE)- THEORY- (a) RPE-01- PHILOSOPHY AND ETHICS- (03 hrs)- (1) Introduction to Philosophy: Definition, nature and scope, concept and branches (2) Ethics: Definition, moral philosophy, nature and moral judgments and reactions, (b) RPE-02- SCIENTIFICCONDUCT-(5hrs)-(1) Ethics with respect to science and research, 2. Intellectual honesty and research integrity, 3. Scientific misconducts: Falsification, Fabrication, and Plagiarism(FFP),4. Redundant Publications: duplicate and overlapping publications, salami slicing, 5. Selective Reporting and misrepresentation of data. RPE-03- PUBLICATION ETHICS(07 hrs)-1. B. Software tools (02 hrs)- Use of plagiarism software like Turnitin, Urkund and other open source software tools.

The scholars will follow MLA Handbook 9th edition/ APA 7th edition and will have to be consistent in citation following MLA/APA as per their requirement/liking etc.

# 3. Paper-III: Area Study in Literature / Linguistics / Cultural Studies- 4 credits

The area study paper in the Ph.D. research course work comprises of five units. The units are devoted to exploration of theory related to the specific area of research, study of related significant praxis and then the application of the theory in the desired area of literature. The scholar has to show his/her ability and originality in the application of theory in his proposed area of literature. In the present syllabus, the units will have equal weightage in mark distribution in both the internal (40 %) and End term (60 %) examinations.

The scholar in consultation with his supervisor will have to design the syllabus for this paper and submit the same to the DRC/RAC for its approval and necessary approval of the other board/council after which scholar can use the syllabus for his study.

#### **Objectives and Scope:**

- (i) The scholars are expected to make in-depth study of the area of theory they desire to specialize.
- (ii) They are required to gain sound knowledge of the area of literature (the age, trends, concepts, techniques and individual authors and works) where the theory is to be applied.
- (iii) They are also expected to gain knowledge to compare their authors/works with other similar fields of (other) literature(s).
- (iv) They must be aware of their contribution to creation of new knowledge/ application of theory in a novel/ creative way.
- (v) They are required to demonstrate their acquiring of specialized knowledge in seminars, viva voce and internal and external examinations.

African Literature, African American Literature, American Literature, Australian literature, British (English) literature, Canadian Literature, Caribbean Literature, Commonwealth literature, Comparative Literature, Contemporary African/American/ Australian/British/ Canadian/Commonwealth/Comparative/ Indian/Northeast Indian(English)/ Latin American/Russian, etc. Literature, Contemporary Theory, Cultural Studies, Cyber Culture/Literature, Dalit Literature, Different Trends/ Concepts in Literary Criticism, Drama/ Dramaturgy, ELT, Film/ Media Studies, Greek /other Literature in English Translation, Indian Aesthetics/Poetics, Linguistics/ Linguistic Studies, Literature from Third/Fourth World, Morphology, Partition Literature, Phonology, Phonetics, Regional/ Vernacular Literature in English Translation, Religious Literature/Saint Literature, Science Fiction/ Literature, Semantics, Stylistics, Syntax, Translation/ Translation Studies, Women's Studies/ Writing, World Literature, etc. (\* Literature refers to all different forms including ages, concepts, trends, techniques, etc.)

# 4. Paper-IV: Research Paper Writing & Presentations (2 PowerpointPaper presentations with 2 written research Papers to be evaluated)-2 credits: Paper Writing: 60, Presentation: 40
